

Smythesdale Gardens and Brewery Dam Reserve Masterplan - Communications & Engagement Report 26 July to 23 August 2023

Following adoption of the Smythesdale Gardens and Brewery Dam Reserve Draft Masterplan (the Draft Masterplan) at its meeting on Tuesday, July 25, Golden Plains Shire Council sought more community input via survey.

The Draft Masterplan was developed following an extensive community engagement process which included the Smythesdale Progress Association/Committee of Management (CoM) taking part in a site walk through and a consultation session where they shared their views on site issues and constraints, and identified opportunities for improvements.

Key objectives of the Draft Masterplan include improving and enhancing the reserve landscape, establishing options for additional facilities and infrastructure, improving recreational opportunities for reserve users and resolving access issues.

Expressions of Interest were open to eligible community members from Wednesday 26 July to 5pm, Wednesday 23 August 2023. Throughout this period, there were two submissions received as provided at the end of this report.


The social media campaign for this project was separated into three stages: launch, mid-reminder, and final chance reminder broadcasting over the effective channels.

SUBMISSION 1

How satisfied are you with the Smythesdale Gardens and Brewery Dam Reserve Draft Masterplan? Somewhat Satisfied

Have we missed anything with the Draft Masterplan?

It would be good to see an area preserved for tiny home accommodation probably in the area on the right as you enter to provide easy access to the rail trail.

What three elements of the Draft Masterplan would you like to see implemented first?

We are presently talking to a number of companies who provide the units, promote the availability and pay the host (Progress Association) a fee. This is a component of the Master Plan that may be able to be implemented prior to the formal commencement of Stage 1 of development.

Both areas would contribute substantially to the recreation offering in Smythesdale increasing the community Pride of Place.

Have we missed anything with the Draft Masterplan?

BREWERY DAM

- There is a large bird life population which call Brewery Dam home. The garden bed edges and boardwalk will encroach on their nesting habits.

- The overflow of Brewery Dam marked on the plan is completely different to where it actually happens. We have witnessed it twice in ten years.

- There is a need for smaller native shrubs and understory plants to encourage the return of small native bird varieties.

- Rubbish/recycling bins are a necessity as I am always collecting rubbish and disposing of it in my own bins.

- Dedicated, safe fire pit as they are often started late at night in areas of the bush where a bushfire could easily be sparked.

- Boundary bollards to keep vehicles of the dam foreshore and surrounding bush as 4WDs are often seen on the banks and deeper in the bush.

- Eradication of noxious weeds such as BlackBerry and Gorse.

What three elements of the Draft Masterplan would you like to see implemented first?

Boundary fencing/bollards Rubbish/Recycling bins Removal of noxious weeds

Any other feedback on the Draft Masterplan?

We have lived beside Brewery Dam for over 10 years and see the daily activity in the area. I believe I can assist in regards to the birdlife, wildlife and native flora as I spend a lot of recreational time walking, photographing and enjoying the area. I documented the fungi varieties this past season seeing two very rare specimens.
