Category 2: Standard Registration – CAT Only \$136 <ul style="list-style-type: none"> • Any cat not described under Category 1 	Category 5: Declared Menacing Dog \$209 <ul style="list-style-type: none"> • Any declared Menacing dog
Category 3: Standard Registration – DOG Only \$152 <ul style="list-style-type: none"> • Any dog not described in category 1 	Category 6: Declared Dangerous/ Restricted Breed Dog \$314 <ul style="list-style-type: none"> • A declared Dangerous or Restricted Breed dog
Transferring from another Council - \$10.20 <ul style="list-style-type: none"> • Must be an active registration • Transfers can only occur within Victoria • Proof Required 	Pension Discount – 50% <ul style="list-style-type: none"> • Available only on Category 1, 2 & 3 • Only eligible for persons with a Pensioner Concession Card, Veteran’s Affairs Card or Veteran’s Affairs War Widow Card • Health Care Cards are not accepted.

Important Information

- **Tags:** Your registration tag(s) will remain valid for the lifetime of your animal(s) provided the registration fee is paid annually. Replacement tags can be obtained free-of-charge from any Customer Service Centre.
- **Registration Year:** Registrations are due on 10th April every year.
- **Permits for Multiple Pets:** Under Council’s Local Law No. 2 – General Public Amenity (2017), it is an offence to keep more than two [2] dogs or two [2] cats on a property without a permit. Unless the dogs are kept exclusively for droving or drafting livestock in a rural area. Contact Council for information and permit application forms.
- **Restricted Breeds:** In Victoria are as follows; Pit Bull Terrier, American Pit Bull Terrier, Fila Brasileiro, Fila Mastiff, Dogo Argentino, Japanese Tosa or Perro De Presa Canario
- **Working Dogs:** Means a dog that herds, droves, protects, tends or works stock on land used solely or primarily for primary production. Dogs used for vermin control are not considered working dogs. Breeds include; Border collie, Kelpie, Blue Heeler, Maremma. Working dog statutory declaration must be completed.
- **Approved Organisations:** You may be eligible for the reduced rate if both you and your pet are registered with an approved organisation including Dogs Victoria & Cats Victoria. You can view the list of applicable organisations accepted by the State Government [here](#)
- **Transferring from another Municipality:** Your pet can be transferred from another Victorian council as long as proof of registration is provided. The only fee that will apply when transferring is **\$10.20**
