## IMPORTANT INFORMATION

TAGS	Your registration tag(s) will remain valid for the lifetime of your animal(s) provided the registration fee is paid annually. All dogs and cats over the age of three months must be registered with Council. Council's Community Protection Officers conduct regular inspections to ensure compliance. Owners are liable for a fine if the registration fee is not paid by April 10 each year.
MICROCHIPPING:	As of 1 May 2007, all new applications to register a dog or cat will not be accepted unless the dog or cat has been implanted with a microchip (of which proof must be provided). However this requirement does not apply to dogs or cats currently registered with Golden Plains Shire.
STATE GOVERNMENT LEVY:	Your registration fees include a levy set by the State Government which is used for the promotion of the Responsible Pet Ownership Program.
PRIVACY:	The Golden Plains Shire considers that the responsible handling of personal information is a key aspect of democratic governance, and is strongly committed to protecting an individual's right to privacy. Council will comply with the Information Privacy Principles as set out in the <i>Privacy &amp; Data Protection Act 2014</i> . Council has in place a standard operating procedure that sets out the requirements for the management and handling of personal information. The information provided on this form is subject to Section 18 of the <i>Domestic Animals Act (1994)</i> and will be used to update the Public Animals Register as required.
PERMITS FOR MULTIPLE PETS:	Under Council's Public Amenity, Roads and Streets Local Law No2 (2007), it is an offence to keep more than 2 dogs or cats on a property without a permit unless the dogs are kept exclusively for droving or drafting livestock in a rural area.
