Good evening everyone.

I would like to say a few words about this last year I have served as Mayor of Golden Plains Shire. It has been an absolute honour to serve my community and represent Council over the last year and I am pleased to have had the opportunity. It has been a year of challenges and achievements for me, but also for Council and residents of our Shire.

The recent community feedback about the rates was a challenging time for us as a Council group, but I truly believe it will result in a better Budget review process next year. The community conversation post in Teesdale ended up being a highlight for me, as it gave us the opportunity to speak and connect with concerned residents and allay some of their fears and concerns.

Community engagement overall has actually been a really positive aspect of my year as Mayor. It has been fantastic to see the organisation, and Councillors, reaching out more and more over this past year. Participating in many conversation posts, events, openings, announcements and other occasions has meant that I have been able to connect with many residents and stakeholder groups. The difference between serving our community as a Councillor and as Mayor has been a revelation to me.

I made sure I prioritised attending as many local events as possible – I genuinely believe being involved and visible to our residents should be a priority for the Mayor. I have especially enjoyed pushing and advocating for our Shire's essential projects and building better relationships with State and Federal Government representatives. Having heard from the two nominees the vote was now put. The Chair called for a show of hands for votes for Cr Sharkey which was 5 and a show of hands for Cr Kirby which was 2.

Cr Sharkey was declared Mayor of Golden Plains Shire Council for the 2018/19 year.

As the incoming mayor I will work closely with my fellow councillors and respect the decisions made by our collective votes that determine Council's direction and decisions.
