

### **Communication channels – best way to communicate**




#### 2020 communication channels – best way to communicate (%)

### Major complaint that influences rating of local sealed roads






#### 2020 major complaint that influences rating of local sealed roads (%)

## Major complaint that influences rating of <u>unsealed</u> roads





### Services or facilities where would like greater investment


