# **Executive Summary**

# What is the Municipal Early Years Plan all about?

The aim of the Municipal Early Years Plan (MEYP) is to provide a strategic direction for the development and coordination of early childhood education, care and health programs and activities that impact on children from birth to the end of primary school in Golden Plains Shire for the period 2014-2018.

## Why have a plan?

All councils must have a MEYP. A MEYP identifies council's role in the provision and support of early years services and infrastructure and focuses on positive outcomes for children and their families.

# What's in the plan?

The plan includes priorities for Golden Plains in the areas of Maternal and Child Health and Early Years services. These priorities have emerged from consultation with the community, service providers and stakeholders. The plan also includes strategies in response to addressing priorities.

- **Priority Area 1. Incorporate children's input into planning:** including regular consultations to gather children's and family views to support the planning and development of services
- Priority Area 2. Support 'whole of Council' approach: establish a Golden Plains Shire State of the Children report, increase awareness of the importance of early years, encourage increased health and wellbeing, encourage access to a range of experiences and services for all children
- **Priority Area 3. Explore Golden Plains Shire as a Child Friendly City**: investigate the advantages and options for Golden Plains Shire to become a child friendly city
- **Priority Area 4. Identify and implement a specific budget for children**: implement the Golden Plains Shire Early Years Infrastructure Plan, and regular consultation with the community
- **Priority Area 5. Advocate for children in Golden Plains Shire:** review funding, service provision and services available to all children and families, advocate with a range of Government departments, facilitate playgroup networks, improve access to Child Care options, establish Early Years Committees in local towns, keep families informed
- **Priority Area 6.** Strive for ongoing improvements in all aspects of direct service provision: engage families with M&CH services, deliver Playgroup Plus across Golden Plains Shire, provide high quality early years services, establish active practice and planning forums, facilitate specific programs to support all children and families, develop skilled volunteer committees to support Early Years and integrate enrolment system for all Kindergartens

#### Introduction

In the middle of 2012, Golden Plains Shire started a process to develop a new Municipal Early Years Plan (MEYP). The aim of the MEYP is to provide a strategic direction for the development and coordination of early childhood education, care and health programs and activities that impact on children from birth to the end of primary school in Golden Plains Shire for the period 2014 - 2018.

Golden Plains Shire is committed to offering "lifestyle and opportunities that foster social, economic and environmental wellbeing. In partnership with the community we will provide strong leadership, encourage sustainable development and ensure quality services, to continue to improve the quality of life of residents." –Golden Plains Shire Vision

# **Development of the Municipal Early Years Plan**

The MEYP was developed after consultation with key stakeholders; primarily families within Golden Plains Shire, Early Years staff and service team leaders. Other data was sourced from several different locations: These are summarised below:

- 1. Current population data by age group (ABS Census data 2011)
- 2. Population projections by age group (Victoria in Future 2012)
- 3. Births and enrolment data (Golden Plains Shire)
- 4. Breastfeeding rates (Golden Plains Shire)
- 5. Measures of vulnerability
  - a. DEECD Early Childhood Community Profile September 2010
  - b. AEDI Community Profile March 2011
  - c. DEECD Kindergarten enrolment data (2009)

## The Policy Context: What this means for Golden Plains Shire

The key relevant policy issues which form the basis for future Early Years planning within the Shire:

- The emphasis on increased integration of early years services through the establishment of community hubs and other integrated service delivery models;
- The increased commitment to universal access to early childhood education
  - 15 hours of Kindergarten per week for a minimum of 40 weeks per year, delivered by degree qualified early childhood teachers, for every four year old child in Australia by 2013;
- The improved links between early childhood services and schools through:
  - o Improved outcomes for disadvantaged children;
  - o Early childhood workforce reform;
  - o Improving quality in early years services.
- The strengthening of participation rates for Maternal and Child Health Ages and Stages
- The reduction of children who are not developmentally "on track" by investing in early childhood and in prevention of vulnerability
- The importance of engagement and consultation with parents and children in the community
- The emphasis on the improvement of early childhood infrastructure development and planning

# Council's future role in Early Years services

Historically, Golden Plains Shire Council has been the main service provider for Early Years services across the Shire. Some Early Years services have been provided independently from Council, e.g. some Occasional Child Care services or community managed kindergarten. Council has provided Maternal and Child Health, Long Day Care, Occasional Child Care, Family Day Care and Kindergarten Cluster Management. The environment that created the need for a strong Council service delivery role has now changed with a rapidly increasing population and more service providers exploring opportunities to extend into the Golden Plains Shire.

Golden Plains Shire Council has a dual role, including both service delivery and a significant role in planning for Early Years services. The Victorian Department of Education and Early Childhood Development have an expectation that Council will lead the planning for Early Years services in the Shire. This has created a policy and business environment where Council needs to consider its role going forward, and may need to have a reduced role away from direct service provision and an increased role in high level planning.




Figure 1: Golden Plains Shire





Table 4: Current population by age 0-4 years (selected towns and SLA)





# **Community Consultation**

A community consultation process was undertaken during November and December 2012 to identify actions and priorities for the new MEYP. Council engaged Springtech Services to assist in the development of the new MEYP and undertake the consultation process.

The consultation process involved individual interviews, some focus groups and a survey that was available in both a paper based and an online version. There was a total of 155 survey responses, with a further 126 participants interviewed or involved in the focus groups (a total

of 281 participants). Results from the surveys were generally similar to findings from the interviews and focus groups. All of the results from the consultation process have been included in the MEYP Background Paper.

The following recommendations have been developed after reviewing outcomes from the community consultations.

#### Community Consultations – What does the community want Council to do?

#### **Golden Plains Shire**

- 1. Advocate for a High School within the shire, including exploring the possibility of a new K-12 school in Bannockburn.
- 2. Continue to invest in playgroups and kindergartens.
- 3. Advocate for primary schools in local communities (e.g. expansion at Bannockburn, viability at Shelford, Linton and Cape Clear)
- 4. Explore options for increased access to child care services throughout the shire.
- 5. Explore options for before and after school care and children holiday programs for all ages.
- 6. Advocate for increased access to walking paths, bike tracks, outdoor areas, pools, playgrounds, pedestrian crossings (including road traffic assessments to see if lights or roundabouts are needed in some areas).
- 7. Advocate for maintenance of early years infrastructure.
- 8. Advocate and facilitate access to health services, including access to General Practitioners and counselling services.
- 9. Advocate for an ambulance service to be based within the shire.
- 10. Advocate and facilitate access to information for new residents and families who live in the Shire.
- 11. Advocate for continued involvement and support by Shire Council.
- 12. Advocate and facilitate a range of community events that increase the high level of community spirit and wellbeing.
- 13. Advocate for a swimming pool within the Shire.

# Consultation with Key Stakeholders

Two consultations were undertaken during May 2013 with key stakeholders to discuss the draft MEYP. The first consultation was held with Golden Plains Early Years staff. Outcomes from the consultation were incorporated into the draft MEYP. The second consultation was held with Golden Plains Team Leaders who provided feedback on how the MEYP would fit with their own teams.
